

POLICY STATEMENT

On behalf of Cambridge Computer Services, Inc. (CCS), this is a statement of intention to make all reasonable efforts to live up to its Equal Opportunity policy and Affirmative Action Plan. The Plan has been prepared to accurately reflect the company's current status, its actions to date, and its intentions for the future. The President & CEO has expressed support for the Affirmative Action Plan and assigned overall responsibility for fulfillment of the Equal Employment Opportunity policy and Affirmative Action Plan to Joseph Hickson who will periodically conduct analyses of all personnel actions to ensure that the company is living up to its stated intention.

The management of the company is responsible for the ongoing monitoring of all personnel actions in their respective areas of supervision, and will carry out the intentions of the Equal Opportunity policy and Affirmative Action Plan to the fullest extent possible.

PAY TRANSPARENCY NONDISCRIMINATION PROVISION
